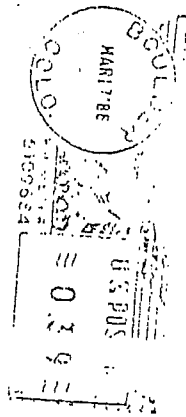

00001 **NATURE OF REPORT**. ON 01/26/85, AT APPROXIMATELY 1605 HOURS, I WAS
 00002 RADIO DISPATCHED TO 3825 SPRING VALLEY ROAD, REFERENCE A MISSING PERSON.
 00003 I ARRIVED ON THE SCENE AT APPROXIMATELY 1645 HOURS.

00005 **INTERVIEWS**: UPON ARRIVAL AT THE SCENE I WAS CONTACTED BY LOIS A.
 00006 FURTELL, AND TOM MYERS. FURTELL ADVISED ME THAT GARY J. BALDWIN, HAD
 00007 BEEN STAYING WITH HER AND MR. MYERS FOR THE LAST SEVERAL WEEKS. SHE
 00008 STATED THAT BALDWIN HAD BEEN VERY DEPRESSED LATELY AND WAS HAVING
 00009 FINANCIAL PROBLEMS. SHE STATED THAT SHE HAD NOT SEEN BALDWIN FOR
 00010 SEVERAL DAYS, NOT SINCE THURSDAY, 01/24/85, AT APPROXIMATELY 0800 HOURS.
 00011 SHE SAID THAT IT WAS VERY UNCOMMON FOR HER TO NOT HEAR FROM OR SEE
 00012 BALDWIN AT LEAST ONCE A DAY AND THAT ON THIS DATE, 01/26/85, SHE HAD
 00013 RECEIVED A LETTER FROM BALDWIN WHICH HAD STATED THAT SHE AND MYERS HAD
 00014 ALWAYS BEEN BALDWIN'S FRIENDS, BUT THAT EVEN THEY COULDN'T HELP ANYMORE.
 00015 FURTELL STATED THAT FROM THE TONE OF THE LETTER, SHE WAS CONCERNED THAT
 00016 BALDWIN MIGHT INTEND TO HARM HIMSELF, AND THAT SHE HOPED THAT HE COULD
 00017 BE LOCATED IN ORDER TO CONFIRM HIS WELFARE.

00019 BOTH FURTELL AND MYERS SPOKE OF THE POSSIBILITY THAT BALDWIN EITHER
 00020 INTENDED TO COMMIT SUICIDE, OR INTENDED TO LEAVE THE COUNTY AND ASSUME
 00021 ANOTHER IDENTITY IN ORDER TO ESCAPE HIS FINANCIAL OBLIGATIONS. BOTH
 00022 FURTELL AND MYERS WERE QUICK TO POINT OUT THAT THEIR THOUGHT WERE
 00023 MERELY SPECULATION, AND WERE NOT SUBSTANTIATED BY ANY HARD EVIDENCE.
 00024 FURTELL STATED THAT BALDWIN HAD SPOKEN OF GOING TO THE HAWAII ISLANDS AND
 00025 ALSO POINTED OUT THAT BALDWIN HAD SEVERAL BOOKS ON THE PACIFIC ISLANDS
 00026 AT THE RESIDENCE. FURTELL STATED THAT MANY DIFFERENT PARTS OF THE BOOKS
 00027 HAD BEEN UNDERLINED AND HIGHLIGHTED, AS THOUGH BALDWIN HAD SPENT QUITE
 00028 SOME TIME REVIEWING THEM. FURTELL AND MYERS BOTH STATED THAT THEY FELT
 00029 THAT BALDWIN HAD SEVERAL FREE PLANE FLIGHT COUPONS FOR EITHER
 00030 CONTINENTAL AIRLINES OR UNITED AIRLINES.

00032 FURTELL STATED THAT THE LAST TIME SHE SPOKE WITH BALDWIN ON THURSDAY,
 00033 01/24/85, BALDWIN HAD STATED THAT HE WAS GOING TO TEXAS ON BUSINESS.
 00034 FURTELL STATED THAT SHE HAD CHECKED WITH BALDWIN'S WORK, JET SERVICES,
 00035 AIRCRAFT CHARTER AND MANAGEMENT AND HAD FOUND OUT FROM THE WORKERS THERE
 00036 THAT THE LAST TIME BALDWIN WAS SEEN AT WORK WAS WEDNESDAY, 01/23/85, IN

00042 MYERS AND FURTELL ALSO NOTED THAT BALDWIN HAD IN THE PAST BEEN DIAGNOSED

00075 SECRETARY TREASURER OF JET SERVICES. MR. DAIB STATED THAT MR. BALDWIN
00076 WAS HAVING FINANCIAL PROBLEMS. DAIB WENT ON TO SAY THAT A NOTE HAD BEEN
00077 FOUND ON MR. BALDWIN'S DESK AT APPROXIMATELY 1030 HOURS ON 01/27/85. THE

00103 JET SERVICES, JEFFCO AIRPORT, 469-5387. AT THIS TIME, I SPOKE WITH THE
